## Section 4 – Sector Program Provider Eligibility and Information

15. Is the organization operating the sector program (and that is a partner on this project) a nonprofit?

Organizations operating the sector programs being studied must be nonprofits. Sector programs primarily run by technical or community colleges, for profit organizations, or public agencies are not eligible for STEP. Nonprofits that run sector programs and partner with other organizations to offer services, including those not eligible to be the lead organization, are eligible for STEP. *[Must select "yes" to proceed.]*

We do not have a strict definition of "low income" for STEP. Please use a definition that makes sense for the sector program you are evaluating. Your definition may be based on participants' wages or income; a defined measure such as the Federal Poverty Level or living wage; a proxy measure such as being eligible for means-tested federal programs like SNAP or TANF or being Pell-eligible; or another measure that makes sense in the program's context. *[Must select "yes" to proceed.]*

17. In which sector(s) does the organization operating the sector program provide training? Please only list the target sector(s) of the training(s) that will be evaluated as part of this project (e.g. advanced manufacturing, IT, health care).
18. For which occupation(s) do these trainings prepare individuals? Please list the occupations participants can obtain directly following training completion, and not downstream occupations that the training does not directly prepare participants for.
19. What credentials or certifications does the training result in? These can be industry recognized or program specific credentials.
20. Please describe why the sector program provider (the organization running the sector program being evaluated) and the sector program itself are well-positioned to be supported by an evaluation in partnership with external researchers.

The **sector program provider's** readiness can be demonstrated by noting past or current evaluation efforts the organization has been involved in, the strength of the relationship between the organization and the researcher, or the organization's data infrastructure, among other related factors.

The **sector program's** readiness can be demonstrated by noting how the program aims to improve employment outcomes, how long the program has operated, the program's participation and employment-related outcomes, how the program adapts to industry and employer input, or the program's screening and supportive services offerings, among other related factors.

You do not need to speak to all of these dimensions. Please limit your response to no more than 500 words.

## Section 6 – Project Narrative

Please briefly describe your proposed project, its importance to the field, and how it contributes to building evidence about sector programs, including:

- A description of the sector program(s) you will be evaluating. For example, the program services or components, the program length, how the target sector/occupations were selected and the quality of the target occupations, the program's relationship with employers, specific populations targeted, and other relevant characteristics.
- Clearly stated research questions and how they align with the project's prioritized research questions and evidence building goals
- The methodological approach or research design, a brief rationale of why that design is appropriate for your proposed research questions, and your proposed key outcomes and data sources
- What makes your project a good fit for STEP, including how it speaks to STEP's three priorities of:
  - Having an equity-focus: can be related to project team diversity, participatory research methods, analysis methods, research questions, target populations, or another dimension
  - Relevance to the field: meaning the findings fill an evidence gap or can be used by other programs or the field to improve practice
  - Informing how to increase the reach of sector programs through objectives such as building evidence on how sector programs can effectively serve more or different types of learners, understanding barriers and facilitators of sector program expansion, improving the strength of the sector program for key populations, etc.

Please limit your response to 1,500 words. You will be asked to further expand on these and other factors during the Proposal stage.
